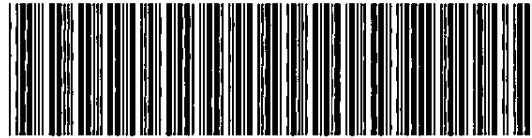

**Article I
Name**

The name of this corporation is KARUSSELL, INC.

**Article II
Principal Office Address**

**Article III
Nature of Business**
