

ARTICLE XI- AMENDMENT

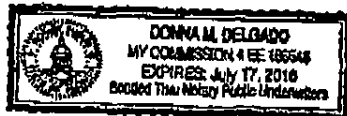


