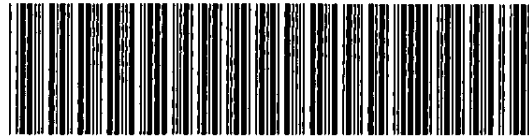



ARTICLE 1


