

ARTICLES OF INCORPORATION OF SUCCESS PARTNERS GROUP HOMES, INC.

The undersigned do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE 1 - NAME AND ADDRESS

The name of this corporation is Success Partners Group Homes, Inc. and the address is 13211 NW 26 Court, Miami, Florida 33167.

ARTICLE II- PURPOSE

This corporation is organized for the purpose of:

- 1. Transacting any and all lawful business for which a corporation may be incorporated under Florida Statues.
- Providing housing, program development/management & technical assistance, individual and group direct support, and advocacy services. Also providing consultant services to entities serving, and to individuals designated as developmentally challenged or otherwise dependent, and incapable of unassisted living.

ARTICLE III – CAPITAL STOCK

This corporation is authorized to issue 100 shares of no par value common stock, which shall be designated as "Common Shares". All of said stock shall be payable in cash or property (real or personal) at just valuation to be fixed by the Board of Directors.

ARTICLE IV- VOTING

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding Common Shares, with one vote cast per share.

ARTICLE V – TERM OF EXISTENCE

This corporation shall commence at the time of filing of these articles and shall have perpetual existence.

ARTICLE VI- PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class, or series as that which he/she already holds, shall have the right to purchase his/her pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the prices at which is offered to others.

ARTICLE VII - INITIAL REGISTERED OFFICE AND AGENT

ARTICLE XI- BUSINESS TRANSACTIONS

No contract or other transaction between this corporation and any other corporation, and no act of this corporation shall in any way be affected or invalidated by the fact that any of the directors of this corporation are directors, or officers of, such other corporation. Any director individually, or any firm of which any director may be a member, may be a party to any contract or transaction of this corporation, provided the fact that he or such firm is so interested shall be disclosed or shall have been know to the Board of Directors or a majority thereof, and any director of this corporation who is also a director or an officer of such corporation, or who is so interested may be counted in determining the existence of a quorum at any meeting of the Board of Directors of this corporation which shall authorize any such director or officer of such other corporation, or not so interested.
