The general nature of this business and the objects and purposes proposed to be transacted and carried on sale of art work to the same extent as natural persons might or could do and specifically the Corporation may engage in any activity or business permitted under the laws of the United States and/or the State of Florida.

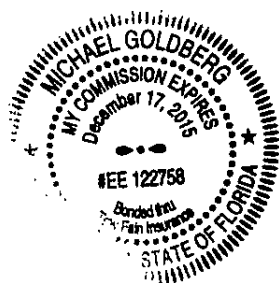
