ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF ALEXANDRE EMMANUEL BURKHARDT, P.A.

THESE ARTICLES OF AMENDMENT ("First Amendment") TO THE ARTICLES OF INCORPORATION OF ALEXANDRE EMMANUEL BURKHARDT, P.A. ("Company"), a Florida corporation, is made as of this 12 day of April 2013 pursuant to Florida Statute Section 607. The director of the Company unanimously hereby states as follows:

1. The articles of incorporation of the Company were originally filed on November 14, 2012 and assigned Florida document no. P12000094978.

2. Article IV is hereby deleted and replaced with the following:

The Corporation is organized for the purpose of engaging in matters in connection with real estate for which corporations may be incorporated under Chapter 607, as further provided in Chapter 621, Florida Statutes, as amended.

3. This First Amendment is adopted as of May 22nd, 2013.

4. This First Amendment was adopted at a special meeting of the Board of Directors by unanimous vote and shareholder action was not required.
