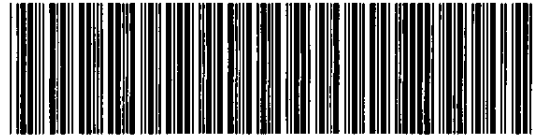

ARTICLES OF INCORPORATION  
OF  
SUNRAIL, INC.

The undersigned incorporator, a natural person more than 18 years of age, in order to form a corporate entity under the Florida Business Corporation Act (Florida Statutes, Chapter 607), adopts the following articles of incorporation.

Article I

Name and Existence

The name of this corporation shall be SUNRAIL, INC. ("the corporation") and it shall have perpetual existence.

Article II

Principal Office

The principal street and mailing addresses of the corporation shall be 3111 Hill Street, New Smyrna Beach, Florida 32169-3555.

Article III

Purpose

The purpose for which the corporation is organized is to engage in privately-owned business or businesses of transporting people and commodities for hire between geographical points of origin and destination, including waypoints; provided, however, that the corporation (a) may engage in other lawful businesses and business activities, and (b) shall neither be nor become affiliated with any local, state or federal government agency.

Article IV

Capital Stock

The corporation shall be authorized and may issue One Thousand (1,000) shares of a single class of non-assesible common stock without par value.

Article V

Officers and Directors

Management of the corporation shall be vested in a Board of Directors having an odd number of members who shall be and remain shareholders throughout their term of

office. The undersigned incorporator shall serve as the president of the corporation for a term of office not to exceed one (1) year from date, or until his successor is duly appointed and qualified by the corporation's board of directors elected at the first annual meeting of its shareholders.

Article VI

Registered Agent

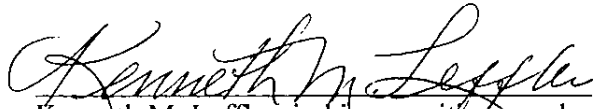
