

ARTICLES OF INCORPORATION  
OF  
JOSEPH M. MOSLEY, P.A.

The undersigned incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is:

ARTICLE II - PRINCIPAL OFFICE
