

ARTICLES OF INCORPORATION
of

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida. Providing for the formation, rights, privileges, immunities, and liabilities of incorporation for profit.

ARTICLE I

The name of the corporation should be:

ARTICLE II

The corporation will engage in any activity or business permitted under the laws of the State of Florida and the United States of America

ARTICLE III

The maximum number of shares, which the corporation is authorized to issue and have outstanding at any one time, is 100 shares of common stock, one dollar (\$1.00) par value.
All stock is to be issued as fully paid and exempt from assessment.
