ARTICLES OF INCORPORATION

OF

The undersigned incorporator to these Articles of Incorporation, a Florida corporation, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - CORPORATE NAME

The name of the Corporation is CHANDPUR ENTERPRISE, INC.

ARTICLE II - NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation is to engage in the operation of a laundromat, including but not limited to maintaining a steam laundry operation, and performing all and every kind of laundry work and services, including but not limited to wet wash, dry, dry clean, apparel, clothing and/or fabrics of any kind; and the sale of related goods, products, and services, on its own behalf and on behalf of others; and to engage in any other lawful activities within the purposes for which corporations may be organized under the Florida Business Corporation Act.

**ARTICLE III - CAPITAL STOCK**

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is One Thousand (1,000) shares of common stock having a par value of One Dollar (\$1.00) per share.

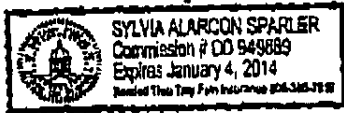
