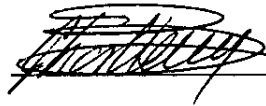
ARTICLE X

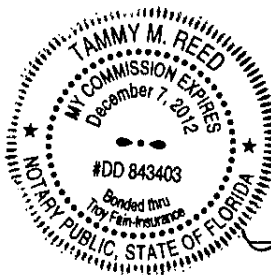

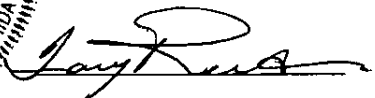

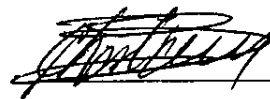
