

ARTICLES OF INCORPORATION OF CIP PEO V, INC.

The undersigned, acting as incorporator of a business corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation for such business corporation.

<u>ARTICLE I - CORPORATE NAME</u>

The name of the corporation shall be:
