Articles of Amendment to Articles of Incorporation

Pursuant to the provisions of Section 607.1006, Florida Statutes, FC LAND DEVELOPMENT CO., a Florida corporation, adopts the following amendment to its Articles of Incorporation:

ARTICLE I
