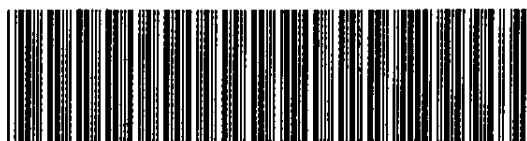



1. Introduction. Juan Serrano, being duly sworn, deposes and says:



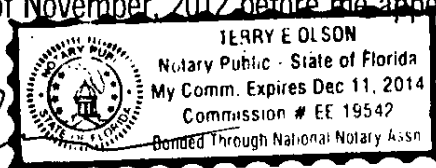
