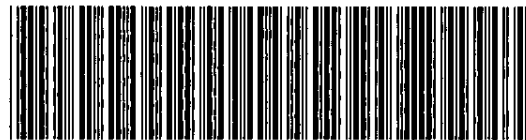

ARTICLE V

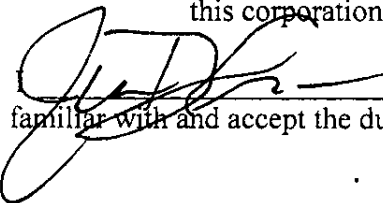
PRE-EXPTIVE RIGHTS

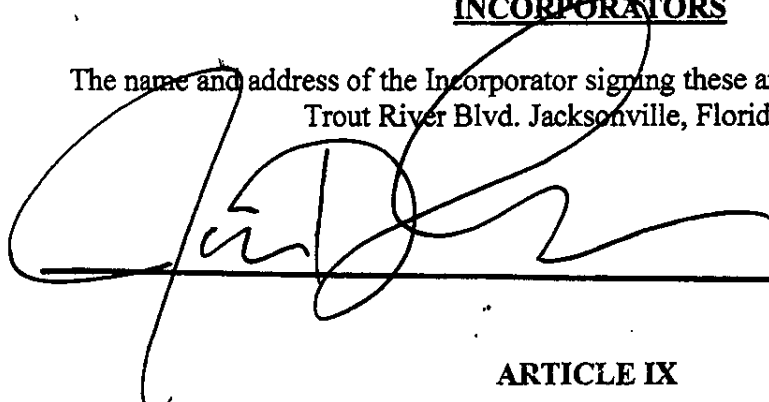
