1. Introduction. Rembrandt Gray, being duly sworn, deposes and says:

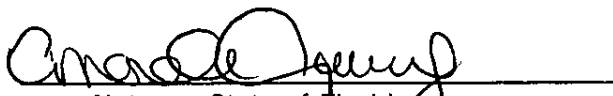

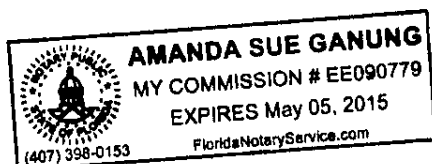
