**ARTICLES OF INCORPORATION
OF
ALPHA BUILDING SERVICES, INC.**

In compliance with the requirements of Chapter 607, Florida Statutes, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a Florida business corporation.

**ARTICLE I
Name**

The name of the Corporation shall be Alpha Building Services, Inc.

**ARTICLE II
Purpose**

The Corporation shall have the power to engage in any lawful business.

**ARTICLE III
Principal Office and Mailing Address**

The principal place of business and mailing address of the Corporation shall be 6627 Willow Park Drive #201, Naples, Florida 34109.

**ARTICLE IV
Capital Stock**

The maximum aggregate number of shares that the Corporation shall have authority to issue and to have outstanding at any one time is One Thousand (1,000) shares of Common Stock. Common shares shall be the only class of shares which the Corporation shall have authority to issue.

Amendment

The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

ARTICLE VIII
Amendment of Bylaws

The Bylaws of the Corporation may be amended by majority vote of either the Directors or by a vote of sixty percent (60%) of the outstanding Common Stock of the Corporation. Directors shall be appointed as outlined in the Bylaws.

ARTICLE IX
S Corporation

The Corporation shall elect to be taxed as an S Corporation under the Internal Revenue Code. The Corporation shall authorize and issue only one class of stock. No stockholder shall do any act (including the sale or transfer of such stockholder's stock) which shall contravene or revoke the Corporation's election to be taxed as a S Corporation. All issued shares, excluding treasury shares, and all issued securities evidencing the right to acquire shares of the Corporation shall be held of record by no more than One Hundred (100) persons in aggregate.
