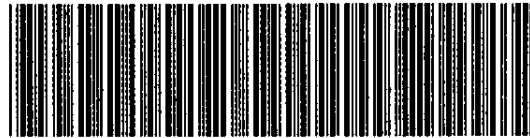

ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator under the provisions of the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of this corporation is: **DONNIE FUSSELL, P.A.**

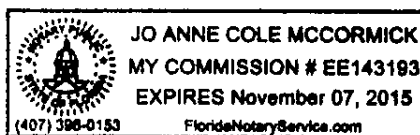
