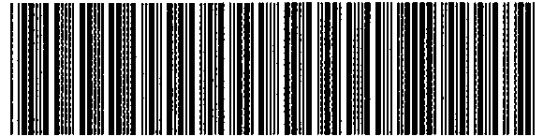

ARTICLE I. NAME

The name of this corporation is
ALL BREVARD POOL SERVICES, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence and shall be
effective on January 1, 2013.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of transacting any
or all lawful business.

ARTICLE IV. CAPITOL STOCK

This corporation is authorized to issue 100 shares of \$1.00 par

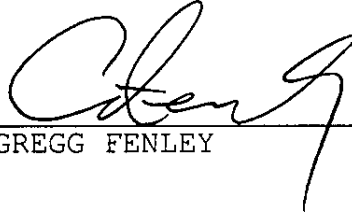

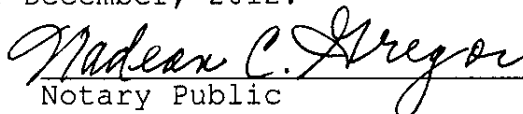

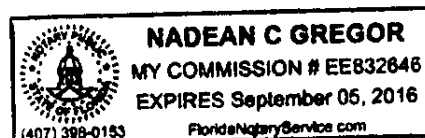
