OF

The undersigned, acting as the Incorporator of RBI Solutions, Inc., a Florida corporation (the "Corporation"), pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for the Corporation:

ARTICLE I - NAME

The name of the Corporation is RBI Solutions, Inc. The street address of the Corporation shall be 6000 Marina Dr., Suite 108, Holmes Beach, FL 34217. The mailing address of the Corporation shall be P. O. Box 1367, Holmes Beach, FL 34218.

ARTICLE II - CORPORATE EXISTENCE

The Corporation will exist commencing on the date of filing these Articles of Incorporation with the Florida Department of State.

ARTICLE III - DURATION

The Corporation shall exist perpetually.

ARTICLE IV - PURPOSE
