

ARTICLE I
Name of Corporation

The name of this corporation is FLORIDA INVESTIGATIVE & PROTECTIVE AGENCY INC.

ARTICLE II
Purpose

FLORIDA INVESTIGATIVE & PROTECTIVE AGENCY INC. is organized to provide investigation and protection services. With the approval of its Board, the company may transact in any and all other lawful businesses permitted under the laws of the United States and the State of Florida.



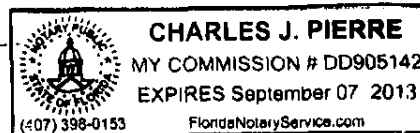
