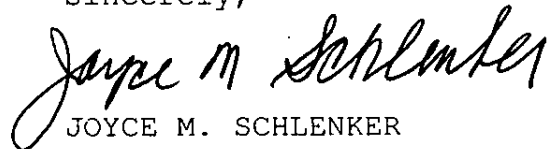

ARTICLE I. NAME

THE STATE DATE 1-1-13
