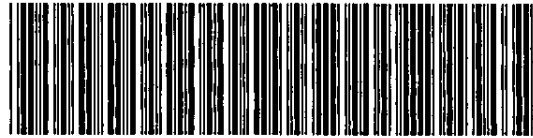

### ARTICLE I

(Name)

(Purpose)

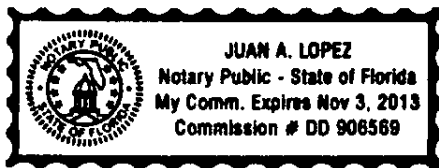


