**ARTICLES OF AMENDMENT TO
THE ARTICLES OF INCORPORATION
OF
DUSTIN BRIMBLECOM, M.D., P.A.**

A. The name of the corporation is Dustin Brimblecom, M.D., P.A. (the "Corporation").

B. The Articles of Incorporation of the Corporation were filed with the Florida Secretary of State on December 27, 2012.

C. An amendment to the Articles of Incorporation was adopted on July 15, 2014 by the sole shareholder of the Corporation to amend and restate ARTICLE I of its Articles of Incorporation in its entirety to read as follows:
