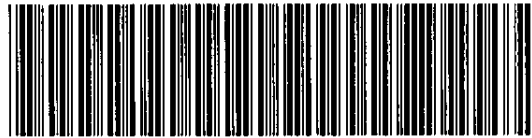


A. The name of this corporation is SUNBELT NATURAL FOODS DISTRIBUTION, INC.
