**ARTICLES OF INCORPORATION  
OF  
BIKE CONCEPTS USA, INC.**

The undersigned, acting as the sole incorporator, desiring to form a corporation for profit pursuant to the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I - NAME OF CORPORATION**

The name of the corporation shall be: **BIKE CONCEPTS USA, INC.**

**ARTICLE II - PRINCIPAL OFFICE**

The principal office and mailing address of the corporation in the State of Florida is 1629 Prime Court, Suite 400, Orlando, Florida 32809.

**ARTICLE III - GENERAL PURPOSES**

The general purposes for which the corporation is organized for and may conduct and transact any and all lawful business authorized and not prohibited by the Florida Business Corporation Act.

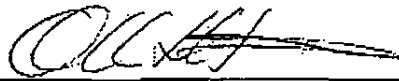
#### ARTICLE VII – BYLAWS
