ARTICLES OF CORRECTION TO AMENDED AND RESTATED ARTICLES OF INCORPORATION OF WEBSTAR NETWORKS CORPORATION

THE UNDERSIGNED hereby executes and swears to these Articles of Correction to the Amended and Restated Articles of Incorporation of Webstar Networks Corporation, a Florida corporation (the "Corporation"), pursuant to § 607.0124, Florida Statutes:

- 1. Name of Corporation. The name of the Corporation is Webstar Networks Corporation.
- 2. Date of Filing of Amended and Restated Articles of Incorporation. The Corporation filed its Amended and Restated Articles of Incorporation (the "Articles") with the Florida Department of State on June 22, 2018.
- 3. Correction to Amended and Restated Articles of Incorporation. Article III, Section 4.2(a) of the Corporation's Articles Amended and Restated Articles of Incorporation incorrectly made a reference Series A Preferred Stock instead of the Series B Preferred Stock and is hereby corrected to read as follows:

Section 4.2. <u>Voting Rights.</u> The holders of shares of Series B Preferred Stock shall have the following voting rights:

(a) Each share of Series B Preferred Stock shall entitle the holder thereof to an number of votes on all matters submitted to a vote of the stockholders of the Company in an amount that shall be equal to 80% of all votes cast at any meeting. To stockholders, or any issue put to the stockholders for voting and the Company may state that any such action was had by vote of all stockholders that exceeded a majority.
