ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF

Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Statutes, Luke's Landscape at The Villages, Inc., a Florida corporation (the "Corporation"), does hereby certify as follows:

1. The name of the Corporation is Luke's Landscape at The Villages, Inc.
2. The original Articles of Incorporation of the Corporation (the "Articles") were filed on December 31, 2012, effective as of January 1, 2013, and assigned Document No. P12000104510.
3. The following amendment to the Articles was adopted by the sole director and the shareholders of the Corporation by written consent dated March 23, 2022, in accordance with the provisions of Sections 607.0821 and 607.0704 of the Florida Statutes. Such written consent of the shareholders represents a sufficient number of votes cast for such amendment necessary for the approval thereof.
4. Article I of the Articles is hereby amended and restated in its entirety and replaced with the following:

"ARTICLE I - NAME

The name of this corporation is Artisan Outdoor Living, Inc."
