AMENDED AND RESTATED ARTICLES OF INCORPORATION OF AT YOUR SERVICE SYSTEMS, INC. DOCUMENT #P12000104585

Pursuant to the provisions of Section 607.1007, Florida Statutes, this Florida profit corporation adopts the following amended and restated articles of incorporation:

FIRST:

Amended and Restated Articles:

ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be AT YOUR SERVICE SYSTEMS, INC.

ARTICLE II - PURPOSE

The general purpose for which the corporation is organized shall be creating IT systems for service companies. It is intended that the corporation is organized for and may conduct and transact any and all lawful business authorized and not prohibited by the Florida Business Corporation Act, as the same may be amended from time to time.
