

(the "Corporation")

EXHIBIT A

The following resolution was unanimously adopted by the shareholders of the Corporation:

Amendments to Articles of Incorporation

RESOLVED, that Article One, of the Articles of Incorporation of the Corporation is amended and shall read as follows:

ONE. The name of the Corporation shall be Presidential Life Insurance Company - USA.

RESOLVED, that Article Five of the Articles of Incorporation of the Corporation is hereby amended and shall read as follows:

<u>FIVE</u>. The number of Directors shall not be less than five (5) nor more than fifteen (15) with the number of Directors to be elected by the Shareholder, at any meeting of or written consent of the Shareholder.

RESOLVED, that Article Six of the Articles of Incorporation of the Corporation is hereby amended to read as follows:

<u>SIX</u>. This Corporation shall have such Officers as may from time to time be fixed by the Board of Directors. All Officers shall hold office for a term of one year unless sooner removed by the Board of Directors.

RESOLVED FURTHER, that the officer of the Corporation, and any one of them in the absence of the others, are authorized and directed to certify adoption of the foregoing resolutions, to file such certificate with the Secretary of State and to take all action necessary to effect the foregoing amendment to the Articles of Incorporation.
