Dear Karon:

As you may recall from our conversation two weeks ago, Teletimer International, Inc. (the "Corporation") has filed suit and is maintaining an action in Florida state court. Under Fla. Stat. Ch. 607.1502(1), the Corporation is prohibited from taking such action if its certificate of authority to transact business is revoked. Currently, the Corporation's certificate of authority is revoked for failure to pay taxes to and file annual reports with the Department of State.

Pursuant to our conversation two weeks ago, I am writing to request that you further notify the Corporation that its authority to transact business in the State of Florida will be revoked pursuant to Fla. Stat. Ch. 607.1530 based on your receipt of the attached duly authenticated certificate from the Secretary of State of Delaware stating that the corporation is no longer in existence and good standing under the laws of the State of Delaware having become inoperative and void as of March 1, 1991 for non-payment of taxes. Thus, in order to have its certificate of authority reinstated and continue its action in Florida state court, the Corporation not only would be required to correct its deficiencies with the State of Florida, but also would be required submit proof of its good standing in the State of Delaware to your office.

In addition, there may grounds for continued revocation of the Corporation's certificate of authority to do business based on the Corporation making a false certification to the Department of State. A certificate of authority, under Fla. Stat. Ch. 607.1530, can be revoked when an incorporator, director, officer or agent of the foreign corporation signs a document that he or she know to be materially false with the intent that the document be filed with the Department of State. The Corporation's certificate of authority previously had been revoked. In December 1996, it submitted an application for reinstatement. A copy of the application is attached. Florida law provides that a corporation can apply for reinstatement by curing the reason for revocation and certifying that the grounds for revocation have been eliminated and no further grounds exist for revocation. Fla. Stat. Ch. 607.15315. When the Corporation applied for reinstatement, its certificate of incorporation had already been declared void for non-payment of taxes. Thus, the Corporation falsely certified that no further grounds for revocation exist. On this basis, continued revocation of the Corporation's certificate of authority may be in order.

At your suggestion, I am requesting a blind copy of the notification that you send to the Corporation. If you have any question please contact me. Thank you for your attention and assistance.
