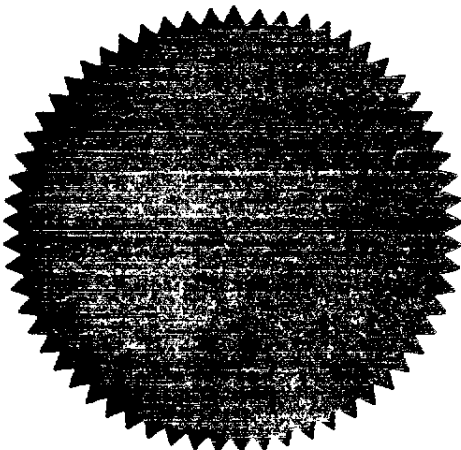
I hereby certify that according to the records in this office, Colonial Leasing Company was incorporated under the General Laws of this Commonwealth on May 16, 1961.
