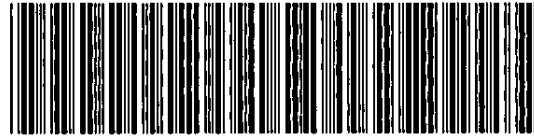



**ARTICLES OF INCORPORATION
OF
CFA SERVCO, INC.**

**ARTICLE 1
NAME**

The name of the corporation is CFA Servco, Inc. (the "Corporation").

**ARTICLE 2
PRINCIPAL OFFICE**

The street address of the initial principal office of the Corporation is 5200 Buffington Road, Atlanta, Georgia 30349.
