1. The name of the Florida Profit Corporation converting into the "Other Business Entity" is CFA SERVCO, INC. (the "Converting Entity").

2. The name of the "Other Business Entity" is CFA SERVCO, INC., a corporation incorporated under the laws of the Commonwealth of Virginia (the "Resulting Entity").

3. The Converting Entity has converted into an "Other Business Entity" in compliance with Chapter 607 of the Florida Act, and the conversion complies with the applicable laws governing the Resulting Entity.


