## ARTICLES OF INCORPORATION

#### ARTICLE I - NAME

The name of the corporation is Geske Management, Inc., at 1268 North Harbor City Blvd., Melbourne, FL 32935 (Principal Office).

#### ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

#### ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any of all lawful business.

#### ARTICLE IV - CAPITAL STOCK

#### ARTICLE VIII - INITIAL BOARD OF DIRECTORS


