# ARTICLES OF INCORPORATION

These Articles of Incorporation are adopted for the purpose of forming a corporation under the laws of the State of Florida, to be filed with the Florida Department of State, as follows:

#### ARTICLE ONE: NAME

It shall be conclusively presumed that at the time of execution and delivery of any document by the corporation affecting any real property or any interest therein, a trust agreement was in full force and effect, such document was executed in full compliance therewith, and the corporation was duly authorized and empowered to execute and deliver such document.
