The undersigned does hereby execute, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida for... the formation of a professional service corporation under the Professional Service Corporation and Limited Liability Company Act and other laws of the State of Florida.

ARTICLE I NAME
