Dear Sir or Madame,

By way of this letter, Alliance Blood Foundation Inc, document number N11000004217, a Florida Not-for-profit corporation (the "Nonprofit") seeks to dissolve the Nonprofit entity and subsequently register a for-profit corporation under the same exact name, Alliance Blood Foundation Inc (the "For-Profit"), with an effective date of the For-Profit corporation of January 1, 2013.

My attorney recently spoke with your department, and was informed that we were unable to do a conversion from a nonprofit corporation to a for-profit corporation, but instead, we would have to dissolve the nonprofit entity and form a new for-profit entity. The agent that we spoke with suggested that I send this letter together with our paperwork to avoid any confusion.

The Nonprofit has yet to commence doing business, has no debts, and was never registered as as nonprofit with the IRS (because it never commenced doing business). As such, being the sole Director of Alliance Blood Foundation, I have determined it is in the best interest of the company to operate as a for-profit corporation.

I have included with this letter Articles of Dissolution to dissolve the Nonprofit as well as Articles of Incorporation to subsequently incorporate the For-Profit corporation. I have also included corporate resolutions authorizing such transaction.

FURTHER RESOLVED, that the President be, and hereby is, authorized and directed to oversee the dissolution of the Nonprofit Corporation and the sale and liquidation of all its assets, if any, to settle all of the Nonprofit Corporation's claims and debts (including all tax debts) to the fullest extent possible, to notify all the appropriate parties of the dissolution, to cancel all licenses, permits, and insurance, and to take all action as deemed necessary by the President or the State of Florida to properly effectuate and record such dissolution and winding down of the Nonprofit Corporation's operations pursuant to Florida law.

FURTHER RESOLVED, that the President shall file Articles of Incorporation to form a For-Profit Corporation under the name Alliance Blood Foundation, Inc. concurrently with the Articles of Dissolution of the Nonprofit Corporation, in order to engage in for-profit activities under such For-Profit Corporation.
