

# ARTICLES OF INCORPORATION OF ADVANCED DIAGNOSTIC IMAGING GROUP, INC.

# **ARTICLE I**

The name of the corporation is ADVANCED DIAGNOSTIC IMAGING GROUP, INC. (hereinafter the "Corporation").

#### **ARTICLE II**
