This Corporation has three (3) officers. The names, titles and address of the officers of this Corporation are:

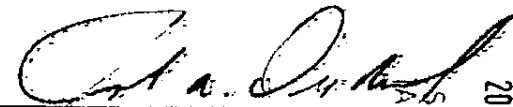
