The undersigned, acting as Incorporator of a Florida corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is Swift Response Exports Inc. (hereinafter, the "Corporation").

ARTICLE II - MAILING AND PRINCIPAL ADDRESS

The mailing address and street address of the principal office of the Corporation is 2960 Weston Road, Suite 200, Weston, FL 33331.

ARTICLE III - AUTHORIZED SHARES

The Corporation's share capital shall consist of a single class of voting common stock. The Corporation is authorized to issue 1,000 shares of its voting common stock, and each share shall have a par value of Five United States Dollars (US\$5.00).
