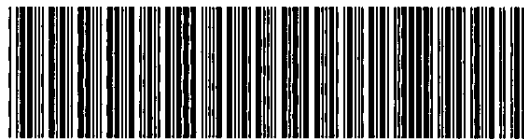

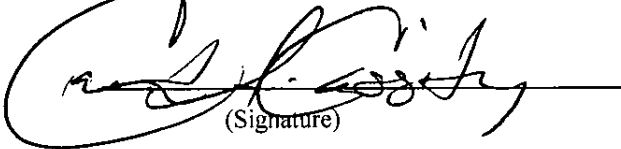
ARTICLE XI
