**RESTATED ARTICLES OF INCORPORATION
OF

Vision Systems North America, Inc., a Florida corporation (the "Corporation"), hereby certifies to the State of Florida Department of State, under a power contained in Section 607.1007 of the Florida Business Corporation Act, as amended, that:
