I, the undersigned, in order to form a corporation under and pursuant to the provisions of the Law of Florida for the purposes set forth below, hereby subscribed to these Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be: WILLIAM A. ESPINOSA, P.A. and its address is: 20872 SW 90th Place Cutler Bay, FL 33189.

ARTICLE II - DURATION

This Corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The purposes and general nature of the business to be conducted and transacted by the corporation shall be as follows.

This Corporation shall indemnify any Officer or Director, or any former Officer or Director to the full extent permitted by law.

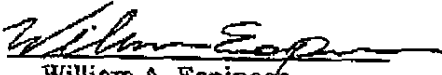
