ARTICLES OF INCORPORATION

OF

ALL CREATIVE HOME SOLUTIONS, INC.

The undersigned, for purposes of forming a corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be ALL CREATIVE HOME SOLUTIONS, INC.

ARTICLE II DURATION

The term of existence of the corporation is perpetual.
