**FINAL JUDGMENT FOR DISSOLUTION OF MARRIAGE**

THIS CAUSE having come before this Court on a final hearing for dissolution of marriage between the Petitioner/Husband, CHARLES PETRUZZI, and the Respondent/Wife, LAURA PETRUZZI, and this Court having heard testimony of the parties, arguments of counsel and otherwise being fully apprised in the premises makes the following findings of fact:


1. This Court has jurisdiction over the subject matter and the Parties.
2. At least one party has been a resident of the State of Florida for more than six (6) months immediately before filing the Petition for Dissolution of Marriage.
3. The marriage between the Parties is irretrievably broken.
4. ~~There are no minor or dependent children common to both parties and the~~  
Respondent/Wife is not pregnant.
5. The Parties have entered into a Marital Settlement Agreement dated April 26, 2013 which is acceptable to both parties.

THEREFORE, it is ORDERED AND ADJUDGED:

- A. The Court dissolves the marriage between the Parties and the Parties are restored to the status of being single.

- B. The Marital Settlement Agreement dated April 26, 2013, which has been filed as an exhibit in this case, is ratified and made part of this Judgment, but not merged herein, and the Parties are ordered to obey all of its provisions.
- C. The Respondent/Wife's name is restored to Laura Vazac.
- D. This Court reserves jurisdiction to enforce any terms and conditions of this Final Judgment.
