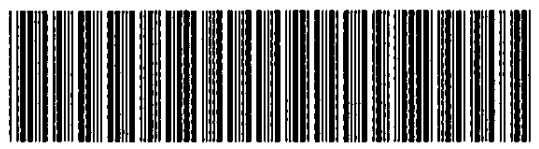

ARTICLES OF INCORPORATION

OF

I.

The name of the corporation is "AMC ONLINE, INC."

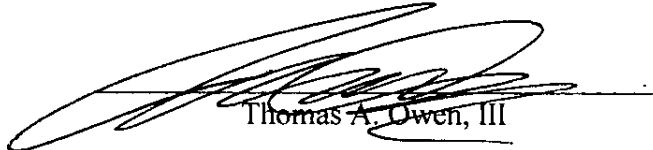

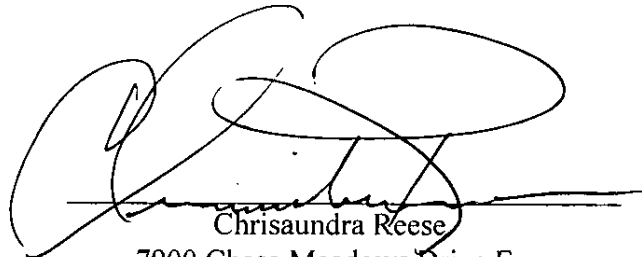
