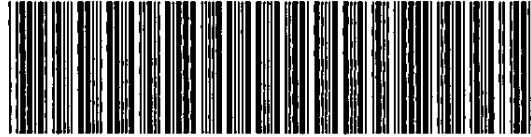

ARTICLES OF INCORPORATION

OF

SCRIBMATIC, INC.

I.

The name of the corporation is "SCRIBMATIC, INC."

II.

The corporation is organized pursuant to the provisions of the Florida Business Corporation Act.

III.

The corporations shall have perpetual duration.

IV.

The corporation is a corporation for profit organized for the following purposes.

- (a) To provide automated internet marketing solutions for small businesses;
- (b) To engage in any lawful business or activity related thereto; and


