ARTICLES OF INCORPORATION OF

The undersigned, acting as incorporator of this corporation (the "Corporation"), pursuant to Chapters 607 and 621 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for the Corporation:

ARTICLE I - NAME OF CORPORATION

The name of the Corporation is "Tampa Institute of Plastic Surgery, P.A."

ARTICLE II - PRINCIPAL OFFICE

The street address of the initial principal office of the Corporation is 277.16 Cashford Circle, Suite 102, Wesley Chapel, Florida 33544.

ARTICLE III - PURPOSE

The general purpose for which the Corporation is organized is to carry on a professional medical practice and related activities.

ARTICLE IV - DATE OF EXISTENCE
