**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
D.H. HOVEY INC.**

D.H. HOVEY, INC., (the "*Corporation*"), a for profit corporation organized and existing under the laws of the State of Florida, in order to amend its Articles of Incorporation in accordance with the requirements of Chapter 607, Florida Statutes, does hereby certify as follows:

1. The Articles of Incorporation of the Corporation were filed with the Secretary of State of the State of Florida on the 31st day of January, 2013, under the name "D.H. HOVEY, INC."

2. The amendment to the existing Articles of Incorporation being affected hereby is a change in the name of the corporation from " D.H. HOVEY, INC." to " J2 HOVEY INVESTMENTS, INC."

3. These Articles of Amendment were unanimously approved by joint written action of the directors and the stockholders of the Corporation the 30th day of November, 2022.

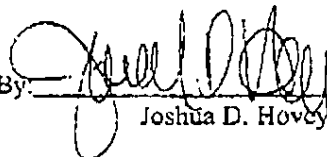

After payment of all required taxes and fees, these Articles of Amendment are to be effective immediately upon filing with the Secretary of State of the State of Florida, at which time the existing Article I of the Articles of Incorporation of the Corporation shall be deleted in its entirety and the following Article I shall be substituted in its place and stead:
